It is designed to support and encourage academic excellence by providing financial assistance to deserving and high-achieving students. This policy outlines the eligibility criteria, application procedures, selection process, and responsibilities of all parties involved, ensuring that scholarships are administered with consistency, fairness, and accountability. Furthermore, it aligns the scholarship programme with the organization's mission, values, and strategic objectives, serving as a comprehensive reference for applicants, evaluators, and administrative staff alike.

## ACADEMIC SCHOLARSHIP POLICY

***Effective from Academic Year 2025–2026***

**(Applicable for MYP5 to IBDP and CBSE students entering Grades 11 & 12)**

### 1. Rationale

This policy aims to recognize and reward exceptional academic achievement among students transitioning from middle school to senior school (Grade 11), either through the IB Diploma Programme or the CBSE curriculum. By offering targeted academic scholarships, the school intends to:

- Motivate/inspire students to strive for academic excellence.
- Retain top-performing students through completion of Grade 12.
- Provide financial support to deserving, high-achieving individuals.
- Create a meritocratic and competitive academic environment that encourages consistent performance.

### 2. Eligibility Criteria for Scholarship Entry

Common Criteria (Applicable to All Streams):

- Conduct and Behaviour: No major disciplinary issues in the preceding academic year.
- Attendance: Minimum **90% attendance throughout the academic year**, unless officially documented exceptions apply.

Specific Criteria – MYP5 to IBDP (DP1 Entry):

- Final MYP5 Examination Score: Minimum 53 out of 56 points.
- Only students meeting these requirements will be eligible for the scholarship starting in DP1.

Specific Criteria – CBSE (Grade 11 Entry):

- Final Grade 10 Board Score (AISSE): 95% and above in five mandatory subjects as per CBSE norms.
- New Admissions: Also considered based on board results and previous school reports.

### 3. Continuation Criteria

DP1 to DP2:

- End-of-DP1 Predicted Grades: Minimum 40 out of 42 points (excluding TOK & EE).

- Subject Performance: Internal assessments must consistently meet grade expectations.
- Behaviour and Commitment: Continued academic integrity, leadership, and attendance.
- Attendance: A minimum of 90% attendance is required in DP1.
- Failure to meet these standards will lead to withdrawal of the scholarship for DP2.

#### CBSE:

- Grade 12 Scholarship Continuation: Scholarship is applicable only for Grade 11 initially.
- Continuation into Grade 12 will be reviewed by the Academic Team and is subject to final approval.

### **4. Multiple Recipients and Fund Distribution**

In both streams, if multiple students qualify for the scholarship in any academic year:

- The scholarship fund will be shared equally among all eligible students.
- It may be allocated proportionally based on performance tiers and/or recommendation of academic committee

### **5. Nature of Scholarship**

- The scholarship primarily recognizes academic merit and considers extracurriculars or leadership roles.
- It may cover a percentage of tuition fees only, subject to the annual school budget and fund availability.
- The exact percentage will be communicated to students and parents/guardians.

### **6. Review and Appeals**

- All scholarships are reviewed by the Academic Committee, which includes Curriculum Coordinators and the respective Principal.
- Students may submit a written appeal in case of perceived miscalculation or oversight.
- The Committee's decision is final and binding.

### **7. Amendments and Exceptions**

The school reserves the right to modify, suspend, or withdraw the scholarship policy partially or entirely due to budgetary constraints or changes in the academic framework.

Exceptional cases or special circumstances may be reviewed independently by the Scholarship Committee for consideration.

## **IPSC Scholarship Policy** -For IB & CBSE students

The Indian Public Schools Conference (IPSC) Academic Scholarship is offered by the IPSC Trust, a separate entity established to support economically disadvantaged but academically deserving students to study in member public schools. The scholarships are provided on a merit-cum-means basis to help them pursue education in these private, elite, and residential schools.

GGs became a member of the Indian Public Schools' Conference (IPSC) as part of its commitment to upholding the highest standards of holistic education, leadership development, and national integration. Aligned with our values of excellence and integrity, IPSC membership was a natural step in our growth. The school met rigorous benchmarks in academics, infrastructure, and co-curriculars to gain acceptance. As part of IPSC, we engage in national academic, sporting, and leadership events that broaden student horizons and foster collaboration.

### **Purpose and Operation:**

- **Merit-cum-Means Basis:** The scholarships are awarded to students who demonstrate both academic talent and financial need.
- Number, amount and **criteria of scholarship** are set by the IPSC governing body which may change every year.
- **Member Schools:** The scholarships are for students attending public schools that are members of the IPSC. Member schools can only recommend, final decision lies in the hands of IPSC governing body
- **Comprehensive Development:** The IPSC aims to foster holistic development, including intellectual excellence, moral character, leadership, and physical well-being, and the scholarships support this goal.
